Dear ally,

The last decade has seen the rise of the “food movement” in the United States, particularly in California. While we all may be more aware of what we eat or where it comes from, we may not be aware of an important coalition of organizations working in our own backyard to leverage the power of food system change as a vehicle for building community, improving public health and individual wellbeing, stimulating our local economy, stewarding natural resources, and promoting social equity. That coalition is the [Sonoma County Food System Alliance \(SCFSA\)](#), and we would like to introduce you to our work and invite your financial support.

The SCFSA is a group of diverse community stakeholders including food producers and distributors, food security organizations, public health advocates, and other community leaders working to improve our food system through community engagement and collective action. Convened through a partnership between [Ag Innovations](#) and the [County of Sonoma](#) in 2009, the Alliance is a powerful tool to bring our community together to target food system issues with collective wisdom leading to effective solutions.

In building their strategy for action, the SCFSA convened the Sonoma County Food Forum in early 2011. Over 300 experts, farmers, food producers and retailers, activists, residents, and elected officials gathered to share their challenges and their dreams for improving our local food system. The Food Forum Report led to the subsequent Community Food Assessment and development of the Healthy and Sustainable Food Action Plan (FAP) – a comprehensive blueprint with a shared vision and goals for our local food system. The FAP has been adopted by the County, and 7 city governments as its formal vision for the future of the local food system.

Since the release of the FAP, the Alliance has been hard at work leveraging the endorsements and involvement from local government and business to build programs, policies and strategies for enhancing our agricultural and natural resources, stimulating the economic vitality of our food sector, encouraging healthier eating (particularly among our most vulnerable populations), and addressing social equity issues that cause hunger and food insecurity in our community.

The staff support to enable this work has been provided by Ag Innovations, a Sebastopol-based nonprofit facilitation firm that has been working throughout California since 2000 to convene community leaders to improve regional food systems and tackle the biggest issues facing California’s ag and food systems (e.g., food safety, water, farmworker housing, ag land loss, etc.).

**Historically, funding for this work has come from the County of Sonoma and the US Department of Agriculture, although current funding is due to expire later this year – hence, this appeal to you now.**

The SCFSA is the only group of its kind in Sonoma County. Members volunteer their time for this important and necessary work. Ongoing expenses are for facilitation and staffing to support productive meetings, coordinated action, and fluid communications. A modest annual budget of \$25,000 enables this support to continue and allows the Alliance to continue to build upon the great work done to date in improving our local food system.

The SCFSA has leveraged more than \$400,000 in past grants, contracts, and community support – a testament to the tremendous benefit that a coalition of this nature offers a community. These funds have enabled the creation of the Food Action Plan, production of public forums to connect farmers and consumers, and much more.

**We are asking local businesses for sponsorships of up to \$5,000 for the Food System Alliance. Your support will enable the group to continue its important collaborative work in fulfilling the vision and aspirations of our community for a healthier and more sustainable food system.**

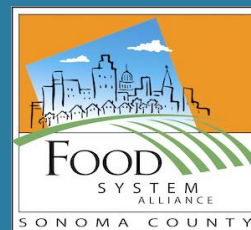

Developed in 2012, the Food Action Plan is a road map with a shared community vision for our local food system. The Food Action Plan (FAP) calls out 11 broad goals for food system improvement in 4 action areas (Pillars).

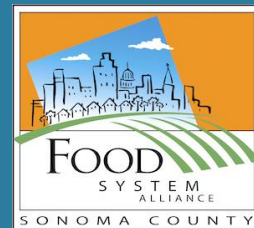

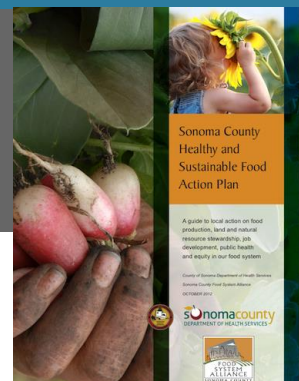
