- Williamson Act/ag land preservation informational and learning session should be moved forward, per request from Amy Chestnut, she can organize the meeting
- Will be forming an Alliance Council in the coming months, focus on statewide networking and cross-alliance collaboration

Amanda: New research paper being released in March/April

<u>Lisa</u>: OAEC is hiring, three positions on website, as well as a school garden teacher training program, application on website: <a href="http://www.oaec.org/school-garden">http://www.oaec.org/school-garden</a>

<u>Phina</u>: Working on gleaning activities in Sonoma Valley, discovered one of the members is attending a preservation class in Placerville and will begin a class in the community kitchen on food preservation. What is the status of master preserver class in the County? Let Phina know.

<u>Trathen</u>: 350 home and garden launch! 2,012 actions is the goal, please spread the word and get involved. Working with Wendy on Cavenaw center with community food forests. Seattle has created and launched a 7 acre food forest, should be modeled in Sonoma Co.

<u>Paula</u>: Encourages members to contact the BOS, they should know the impact on small farmers. So far there has been no movement, FSA may want to put on agenda at some point.

Nica: Santa Rosa Community Market, opening new store at the Barlow, has been part of their strategic plan for years. Will sell meat and beer/wine, highest standards for meat the in the county. 10/1/12 is goal for opening, would like the event to be very community based by having community members stock shelves, etc.

<u>Guy Conner</u>: New select committee on local, organic, and sustainable ag for state senate. Doing research on what legislative, administrative, and regulatory moves that can be done to support farmers and this type of production. Initial meeting will be focused on ag, next convening will be focused on sustainable ag. He is currently gathering information, and would appreciate any references members can send him.

<u>Elizabeth McCarthy</u>: Point of contact and local liaison for Senator Noreen Evans. The committee is statewide, hearing will also be focused on local issues, as well.

<u>Wendy</u>: Sent list of symposiums, see Events. CAFF collaborating with Farmtrails to table at the Gravenstien and Heirloom Festival. Gravenstein will be much bigger this year, held at Ragle Ranch.

<u>Alex Dolginow</u>: Climate Protection Campaign

<u>Terry</u>: KRCB segment is in the works, and he is hoping to find reps for the segments, especially among members. Hoop Fund, which facilitates crowd funding- how individuals can invest into local enterprises- funding, equity and investing. Hoop fund is collaborating on three projects- Tim Page with Terra/Feed Sonoma to come up with mobile vendors into food deserts, to create demand and hopefully lead to a permanent enterprise.

<u>Jana</u>: Report out of all efforts in the food system, will send an update: FAP and County Lands was on the agenda (get from Jana). Information share, hope to return next month for county lands approval.

#### **Food Action Plan**

- > Stakeholder input is the current focus and push
- > Do we have the right stakeholders? List was distributed and reviewed
  - o Is this doable?
  - o What are the goals and are we meeting them?
  - Are there other stakeholders that need to be considered?
- Would like to send contacts a summary, and meet in person or e-mail them directly?
  Depends on your relationship with them
- ➤ Just have them look at the specific goal focused on their stakeholder group, to provide detailed feedback. They can feel free to review the entire plan
- ➤ There will be an additional level of stakeholders that will be vetted after this phase
- > Specific goals and deliverables are missing, climate action plans? The indicators from the assessment will be incorporated into this document, to have the work of the Alliance build on itself.
- Jana would be happy to attend and support members during these meetings, schedule permitting

### Farm to Institution

- ➤ Second food service workshop is scheduled for 5/17
- Focus will be for community members and parents
- Closing- looking for policy development, through wellness centers or board approval- some percentage of food that will be mandated to be local
- > The various schools and districts are very different, best practices and sharing is key
- > Can facilitate potential funding efforts, as well
- > Concrete outcomes are key- have each group identify the next action steps.

# Comments/Questions

- ➤ More press is key- communications committee can support, Nica knows Bohemian editor & Kids Scoop
- ➤ CAFF: New Food Safety staff will be contact to attend
- ➤ Would like to have the policy proposal, procurement percentage, nailed down by the 5/17 event
- ➤ What are the numbers now and what is realistic and doable? Baseline isn't known, and varies across districts
- Encouragement to push with realistic numbers, but realize each district is different, customize goal accordingly
- ➤ Need to provide strategies to be successful
- ➤ It has been agreed that a county-wide goal is important, but varying budgets, sizes, culture, etc.
- ➤ What about each school creating their own baseline?
  - o Food Service Survey- the feedback on this piece varied
- What we know, what we don't know? Distributors do know and have this information
- Fund development is needed, this data collection piece is expensive and needs a high level of resource
  - o Staffing and survey: it has been identified as a need
  - CAFF does have pending funding
- Universal standards do not work

### **Communication and Outreach Committee**

- ➤ Met earlier in the month to discuss goals, level of commitment
- Design of role is focused on editing/reviewing press releases, then deploying
- ➤ Cathryn can coordinate interest and submissions from other committees
- ➤ Please send all press contacts to Helen to incorporate into press list

### Goals:

- 1. Have the general public aware of what the FSA is and why it exists.
- 2. Tell the FSA story goals, milestones and achievements.
- 3. Create the broader context of the food system work being done county-wide.
- 4. Keep food system advocates informed about FSA work as well as broader food system efforts in the county, including where and how they can support it.
- 5. Build an advocacy community to support local, regional, state-wide and national (i.e. Farm Bill) policy change that benefits FSA goals.

#### Potential 2012 Priorities

- 1. Create FSA media list using Ag Innovations list as a starting place.
- 2. Put together calendar of existing FSA / county events that are relevant to our work. Create calendar on FSA website and Go Local's website.
- 3. Work with Jana to create timeline and role of communications for the Food Action Plan what, to whom, when and why.
- 4. Work with Terry to map potential communications for a KRCB weekly 5 minute spot on local food; potentially pair this with short columns on local food in weekly/monthly local newspapers and for blog on FSA website.
- 5. Create FSA "Annual Report" at end of 2012

### **Local Definition**

- Add in language- for the purpose of F2S/F2I and activities that the FSA is involved in
- ➤ "Local" is used in our FAP:
- 1. **Sonoma County Local**: Grown/raised within Sonoma County
- 2. **Local**: Grown/raised within a 150 mile radius of Sonoma County
- 3. **Regional**: grown/raised within a 250 mile radius of Sonoma County

### Comments/Feedback

- > Remove "local" completely
- ➤ Where did 150/250 come from? Comes from other examples, and is based on from all of Sonoma County
- Local is relative
- This definition is flexible, and has a specific purpose- it is a reference point
- ➤ What is the point of the concept? We want to support farmers, environmental impact, and potential multiplier effect. 250 miles is generous, what is achieving our goals?
- Range allows for decision points: do you purchase an avocado from Chile or Ventura Co.? First choice, then second
- ➤ Go Local survey- regional was 9 counties, consumer identification to So. Co. was strong, interest fell off with CA state

- ➤ Proposal of 1. So Co., 2. 5 counties, 3. 250 miles, and then 4. bottomline/reference to Chile
- ➤ Food miles and method of transport to be considered?
- Proposal of 1. So. Co. 2. regional/5 county 3. regional/250 miles, last: CA
- ➤ Mileage expands the options rather than 5 counties- gets you into the Valley, salad bowl, etc.
- May have to be case by case and a thorough explanation is needed, give examples: average school in So Co buys x amount of fruit, what could be bought locally, regionally, statewide?
- ➤ Three part definition: and not refer to the cluster as local
- > Committee will tease out

### **Events**

- ➤ Heirloom Festival, was a great opportunity for exposure, how could FSA have a presence?
- > Proposal:
  - Two panels: one as an update, second can focus on a "food for all" panel, i.e. with Raul Lozano- Valley Verde, using food stamps for CSAs, outside county projects- regionally
  - Committee is needed, to help develop these panels
  - o Booth for FarmTrails, can include FSA poster
  - Could one of the panels actually be a type of caféstyle, have people engaged on that day
  - The heirloom festival may not be the appropriate venue for this
- Gravenstien Fair
  - Free booths for non-profits
  - Invitation to participate
- > Future forums
  - o What is the strategy?
  - Need to think about issue-specific forums and events
  - o What is our capacity?
- ➤ Jana, Paula and Cathryn can support Wendy and Miriam with this piece

### **FSA Calendar Proposal**
